# Arts and Crafts Application

Join us for the 50<sup>th</sup> Anniversary of the Springtime Tallahassee Festival. With more than 150,000 attendees and featuring the finest arts and crafts vendors, gournet foods, and parade floats from around the Southeast, this is one event you don't want to miss!

### General Jubilee Information & Requirements

- The Jubilee will be held on April 7, 2018 from 9:00 am 5:00 pm on the streets and in the parks of beautiful downtown Tallahassee, Florida.
- Booth space is limited. Applications will be accepted for review until <u>February 15, 2018</u>. If space is available late applications will be considered with a \$25.00 late fee. Please note: acceptance of an application is not acceptance into the Jubilee. Applications will be reviewed for acceptance and notification of acceptance will be given via email and notifications of non-acceptance will be given via email/phone.
- Booth payment must be paid in full and included with this application. Payment will be refunded in full if the application is not accepted.
- Booth cancellations are non-refundable after February 22, 2018. A \$25.00 administrative fee will be charged for cancellations prior to February 22, 2018.
- A \$25.00 NSF (Non sufficient funds) fee will be accessed for any returned checks.
- Vendor fees will not be refunded if the festival must be cancelled due to inclement weather, acts of God, or any other circumstances deemed necessary by Springtime Tallahassee and city officials.
- Craft booths are 10' x 10'. All booths are outdoors and are assigned based on vendor category.
- Booth set up begins at 5:30 am April 7, 2018. Booths must be set up by 8:30 am and disassembled by 6:00 pm.
- All vehicles must be moved to designated parking by 8:00 am or they will be towed from festival grounds.
- Springtime is held outdoors on city streets and in parks. Electricity is available for purchase for \$25.00 per plug (20 AMPS). PLEASE SEE RULES FOR DETAILS.
- An email indicating acceptance in the Jubilee will be sent out in <u>February</u>. Additional booth information, maps, permits, rules and regulations will be mailed in March.
- Vendors are responsible for collecting and paying Florida sales tax.
- Vendors supply their own booth tables, chairs and small tents (no larger than 10x10).
- All vendor tents must be properly weighted down; stakes are not permitted.
- Payment may be made by check, money order, or credit card (Visa, Master Card and American Express accepted). Make checks and money orders payable to Springtime Tallahassee Festival, Inc.

## Arts & Crafts Vendor Rules

The Springtime Tallahassee Jubilee in the Park is open to Artists and Craftsmen selling their own **original** work with no mass produced items or reselling of purchased items allowed. Art and Craft vendors will be accepted based on creativity, appropriateness, quality and originality.

All craft vendors (regardless of past participation photo submissions) must supply up-close and clear photographs with this application (photos <u>will not</u> be returned). Please include: (two) photos of items to be sold, (one) photo of booth, (one) photo of you in the process of creating your items.

- All items for sale must be listed on this application. Items will be subject to acceptance prior to the Jubilee and will be checked during the Jubilee. <u>Quality assurance inspections will take place prior to the opening of the event to ensure all rules and regulations have been met, including, but not limited to, inspections of crafts for "original work." Inspections will also take place during the day.</u>
- Selling non-approved items will result in immediate booth closure and forfeit of booth.
- Exhibitors **may not sell or solicit outside** of your designated booth area.
- Vendors must offer all patrons sales receipts with contact name and phone number clearly stamped or printed on the sales receipt.
- Electricity is available for purchase at \$25.00 per plug (20 amps). You cannot piggyback extension cords into a plug or use a power strip. Extension cords must be grounded (3 prong plugs) and covered or taped down.
- No generators are permitted in the venue.
- All vendors must return a signed General Release Form with application including one witness signature.
